AND WHEREAS the said applicants have by and in their complete specification particularly described the nature of their invention:

AND WHEREAS We, being willing to encourage all inventions which may be for the public good, are graciously pleased to condescend to their request:

KNOW YE, THEREFORE, that We, of our especial grace, certain knowledge, and mere motion do by these presents, for Us, our heirs and successors, give and grant unto the said applicants as joint tenants our especial license, full power, sole privilege, and authority, that the said applicants, and the survivors and survivor of them, and the executors or administrators of such survivor, their or his assigns (all of which persons or person are hereinafter referred to as the said patentees)

by themselves, their agents, or licensees, and no others, may at all times hereafter during the term of years herein mentioned, make, use, exercise, and vend the said invention within our United Kingdom of Great Britain and Northern Ireland, and the Isle of Man, in such manner as to them may seem meet, and that the said patentees shall have and enjoy the whole profit and advantage from time to time accruing by reason of the said invention during the term of sixteen years from the date hereunder written of these presents: AND to the end that the said patentees may have and enjoy the sole use and exercise and the full benefit of the said invention, We do by these presents for Us, our heirs and successors, strictly command all our subjects whatsoever within our United Kingdom of Great Britain and Northern Ireland, and the Isle of Man, that they do not at any time during the continuance of the said term of sixteen years either directly or indirectly make use of or put in practice the said invention, or any part of the same, nor in anywise imitate the same, nor make or cause to be made any addition thereto or subtraction therefrom, whereby to pretend themselves the inventors thereof, without the consent, license or agreement of the said patentees in writing under their hands and seals, on pain of incurring such penalties as may be justly inflicted on such offenders for their contempt of this our Royal command, and of being answerable to the patentees according to law for their damages thereby occasioned:

PROVIDED ALWAYS that these letters patent shall be revocable on any of the grounds from time to time by law prescribed as grounds for revoking letters patent granted by Us, and the same may be revoked and made void accordingly: PROVIDED ALSO, that if the said patentees shall not pay all fees by law required to be paid in respect of the grant of these letters patent, or in respect of any matter relating thereto at the time or times, and in manner for the time being by law provided; and also if the said patentees shall not supply or cause to be supplied, for our service all such articles of the said invention as may be required by the officers or commissioners administering any department of our service in such manner, at such times, and at and upon such reasonable prices and terms as shall be settled in manner for the time being by law provided, then, and in any of the said cases, these our letters patent, and all privileges and advantages whatever hereby granted shall determine and become void notwithstanding anything herein-before contained: PROVIDED ALSO that nothing herein contained shall prevent the granting of licences in such manner and for such considerations as they may by law be granted: AND lastly, We do by these presents for Us, our heirs and successors, grant unto the said patentees that these our letters patent shall be construed in the most beneficial sense for the advantage of the said

COMPLETE SPECIFICATION

Improvements in Deck Chairs and the like.

We, JOHANN BAPTIST WEISS, WILHELM HEINRICH WEISS and HANS WEISS, Citizens of the Austrian Republic, trading as Jon. Weiss & Sohn, of 65, Margaret-5 henstrasse, Vienna V, Austria, do hereby declare the nature of this invention and in what manner the same is to be per-formed, to be particularly described and ascertained in and by the following 10 statement:

The best known form of folding chair comprises two frames adapted to be folded scissor-like in one another, and the cross bars of which carry the fabric seating, 15 the said frames being adapted to be fixed in different positions relatively to one another by means of a supporting frame, the lower cross bar of which engages notches in the toothed rack-shaped rear 20 ends of the longitudinal bars of one of the frames

The described form of folding chair affords, it is true, the possibility of folding it up flat and the chair can be made 25 cheaply, but it is accompanied by several disadvantages which it is the object of the invention to obviate, while preserving the peculiarities and advantages of this generally well-established form of folding

30 chair.

Above all, it is a disagreeable experience that on setting up the folding chair, the supporting frame often falls forward 35 or passes over the rack portion, so that difficulty is experienced in setting up the chair. According to the invention, the three parts: supporting frame, outer According to the invention, the frame and inner frame are prevented in a positive manner from swinging out in the wrong direction. It is then possible to set up the chair quickly and securely and also the transportation and stacking of the folded chairs is substantially facili-tated. This prevention of the several tated. This prevention of the several 45 parts from swinging out in wrong directions. tions is effected according to the invention by providing on one or more of the frame parts one or more stops which, when the supporting frame and the outer 50 frame coincide in the folded up position prevent any forward movement of the supporting frame, and by constructing these or separate stops in such a way as to [Price 1/-]

prevent, at the same time, the supporting frame from passing over the inner frame, 55 so that the several parts can only be unfolded in the correct disposition for setting up.

A constructional form of the invention is shown by way of example in the accom-

panying drawings.

Figure 1 is a side view of the folding chair provided with a stop according to the invention, in the erected position. Figures 2 and 3 show the essential parts 65 of the same chair folded up viewed from the side and from the back, respectively, Figure 4 is a diagrammatic illustration of the stop part. Figure 5 is a diagrammatic illustration of the folding chair

shown in Figures 1 to 3.

In Figures 1, 2, 3 and 5 the two frame parts adapted to fold one within the other are shown at 1 and 2, the part 2, in the constructional example shown, lying within the part 1 in the folded position The rear ends 2a of the longitudinal members of the inner frame are constructed in the usual manner in the form of toothed racks, engaged by the crossmember 3a of the supporting frame 3, so that the folding chair can be fixed at different heights. 4 is the fabric seating, 6 the foot part and 5 are the arm rests. In order now on unfolding, to prevent the supporting frame 3 from taking up the wrong positions 3¹ or 3¹¹ (Figure 1) and to facilitate setting up and folding up, the stop and dog piece 7 is provided according to the invention. This consists of a stirrup character of sists of a stirrup-shaped part 7a, 7b, 7c (Figures 4 and 5) and the stops themselves 7d and 7e. The part 7a is screwed to one longitudinal part of the supporting frame 3. The stirrup 7b, or the stirrup 7b and the stop 7d, then bear against the outer frame 1 and prevent the supporting frame 2 from falling framery into the frame 3 from falling forward into the position 3¹ (Figures 1 and 5). The bevelled stop 7e lies against the end 2b 100 of the longitudinal member of the frame 2 and prevents the supporting frame from passing thereover (into the dot-and-dash position 3^{11} in Figure 1). In addition, on allowing the supporting frame to drop, the rack part 2a is temporarily engaged

by the said stop, so that the setting up and to a certain extent also the folding up of the chair is facilitated.

Instead of a combined stop 7, separate 5 stops corresponding to the parts 7b and 7a respectively, may be provided. For example the supporting frame 3 could be provided with a stop corresponding to the part 7b, for preventing the supporting

part 10, for preventing the supporting 10 frame from attaining the position 3¹, and the inner frame 2 could be provided with a stop for preventing the supporting frame 3 from attaining the position 3¹¹.

The stops may also be provided on both 15 sides of the chair, but generally the provision on one side will suffice.

Having now particularly described and ascertained the nature of our said invention and in what manner the same is to 20 be performed, we declare that what we

1. A folding chair consisting of an outer frame (for example 1) and an inner frame (for example 2) adapted to be folded 25 scissor-like one inside the other and to be fixed relatively to one another by a supporting frame (for example 3), characterised in that, on one or more of the frame parts, one or more stops are provided, which, when the supporting frame

and the outer frame coincide in the folded up position, prevent a forward movement of the supporting frame, and that these or separate stops are so constructed that, at the same time the supporting frame is prevented from passing over the inner frame so that the several parts can only be unfolded in the correct disposition for setting up.


2. A folding chair as claimed in claim
1, characterised in that the stop (for
example 7) is fixed to the supporting
frame, engages the outer frame stirruplike and bears, preferably with an oblique
face (for example 7e), against the inner
frame, so that the supporting frame can
neither fall forward nor pass over the end
of the inner frame.

3. Folding chairs having stops, substantially as described or substantially as shown in the accompanying drawings.
